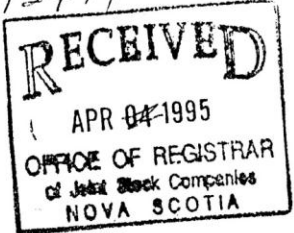

MEMORANDUM OF ASSOCIATION  
OF

Queens Recreational Boating Association

- 1.0 The name of the Society is Queens Recreational Boating Association
- 2.0 The objects of the Society are:
  - (a). To assist members with the development of skills in different aspects of boating and boat related activities.
  - (b). To organize safety, navigational and skills clinics.
  - (c). To maximize the use of existing facilities already available in Queens County.
  - (d). To promote tourism and recreational issues and help to foster an environmental awareness.
  - (e). To provide a recreational and family oriented outlet for all ages.
  - (f). To acquire by way of grant, gift, purchase, bequest, devise or otherwise, real and personal property and to use and apply such property to the realization of the objects of the Society;
  - (g). To buy, own, hold, lease, mortgage, sell and convey such real and personal property as may be necessary or desirable in the carrying out of the objects of the Society.

PROVIDED that nothing herein contained shall permit the Society to carry on any trade, industry, or business and the Society shall be carried on without purpose of gain to any of the members and that any surplus or any accretions of the Society shall be used solely for the purpose of the Society and the promotion of its objects.

PROVIDED, further, that if for any reason the operations of the Society are terminated or are wound up, or are dissolved and there remains, at that time, after satisfaction of all its debts and liabilities, any property whatsoever, the same shall be paid to some other charitable organizations in Canada, having objects similar to those of the Society.

- 3.0 The activities of the Society are to be carried on in the Province of Nova Scotia generally and, more specifically in the County of Queens.
- 4.0 The registered office of the Society is at P.O. Box 228, Brooklyn, Queens County, B0J 1H0.

We the several persons whose names, addresses, and occupations are subscribed, desire to be formed into a Society, in pursuance of this Memorandum of Association.

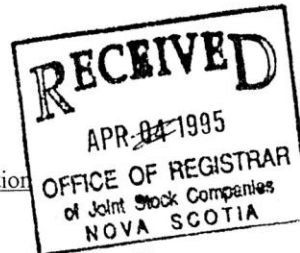
